This abstract should be precise, yet detailed, no more than 200 words long and should contain the following. The primary aims/objectives are not a part of the word count.

## Purpose of the Presentation (200 words or less):

## 1. Detail the purpose of the presentation

e.g. The purpose of this presentation is to introduce the audience to guidelines for hypertension management for African Americans across the life span.

## 2. Specify the audience that would benefit from this presentation

e.g. Because this presentation is about guidelines for hypertension management, it is geared towards staff RNs in all settings, Advanced Practice Nurses, and Nurse Educators.

3. Closing statement should include implications for nursing practice and needs of the consumer.

# **Primary Aims/Objectives of the Presentation:**
